 - ◆ Discussion was had about how many events to hold next year. Vicki motioned that the club hold 6 events next year. Bonnie seconded and all were in favor. The club will definitely hold the fair show, but may forgo other shows in favor for clinics, trail rides, etc.
 - ◆ Trish Switser mentioned that other area horse shows would be interested in pooling resources and maybe creating a series where people could collect points from different area shows towards a year end award. Orleans County and Caledonia County Fair are definitely interested. Emma and Trish will meet with folks from those organizations and bring back information.
 - ◆ Ray Hackett is interested in doing a clinic for us with showmanship in the morning and equitation in the afternoon. He would charge \$400 for the day plus hotel room. Vicki made a motion to book Ray for a clinic, with date to be determined. Jeannine seconded, all in favor.
 - ◆ Discussion was had about requiring anyone participating in club sponsored shows and clinics to be a club member. Bonnie made a motion that participants would not be required to be a member, but non-members would pay a \$10 non-member fee per event. Vicki seconded the motion, all in favor.
 - ◆ Emma met a software developer at Equine Affaire who has horse show software and will be having a zoom meeting with him to get details.
 - ◆ Next meeting will be December 15, 2025 at Weeks Memorial Library, bring your donations for the food pantry.
 - Motion was made to adjourn at 8:09 p.m. by Dave, seconded by Vicki.
