4. <u>Horse Show Report</u>: Cathy Reported:

- 5. <u>Old business</u>:
 - Emma Reported on the by-laws. The club needed to discuss the dispersal of funds to be added into the by-laws. The State of NH requires a 2/3 quorum of remaining board members to vote to disband the club and disperse the remaining funds. The current members felt it should go to a non-profit equine organization or if in the future a named entity is no longer in business, then the by-laws could be changed by the remaining members to disperse the funds. It was decided to name Tom-Ten Farm and Sanctuary and Becky's Gift as equal recipients. Both are non-profits, transparent and reputable. Ramona Motioned to accept this addition to the by-laws being mailed out to members for voting and Vicki 2nd. All were in favor.
 - Damaged Ribbons: There was conversation about what to do with the 38 lbs. of damaged ribbons. Did the club want to set up a time or what were the thoughts about it. Sharon Ellingwood- White spoke about the Creation of a ribbon wall photo backdrop that is still in the creative idea stage. She is collecting ribbons to use the rosettes in memory of Sheryl Stevenson. Trish Motioned to have the club donate the ribbons to this ribbon wall Vicki 2nd and all were in favor. Cathy was going to bring them to Sharon.
 - Brian did not respond to renewing as a member of the club, so he was removed by the President (Emma) as a board member for the reminder of his term 2024.
- 6. <u>New Business</u>:
 - Emma appointed Vicki to Brians board seat for the remainer of 2024. She was the only officer that was not on the board of directors currently, according to the current by-laws.
 - Zoom membership, Club to purchase the yearly membership, 4C Horsemanship is willing to pay \$100 towards this. Zoom to be set up with the club email so Emma and Ramona will set it up. Trish suggested a 1 yr. trial to see how it goes. Cathy motioned to purchase the zoom membership on a 1-year trial basis, Trish 2nd. All in favor
 - Emma brought up going back to every other meeting again this summer. Even months would be meetings. The vote on revised by-laws will be in April so we will need to wait and see if the by-laws pass.
 - Emma to type and forward by-laws to Cathy to get mailed out to every member so they can review and must appear in person to vote or discuss at April meeting.
 - Zeffy.com, Cathy brought up the idea of the club signing up to avoid the credit card fees. This will allow online show sign ups and payments for classes, sponsorships, memberships to not have any fees. 100% of the funds will be deposited to the club. Cathy to bring more information to the next meeting regarding examples.
